INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. The BPI Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

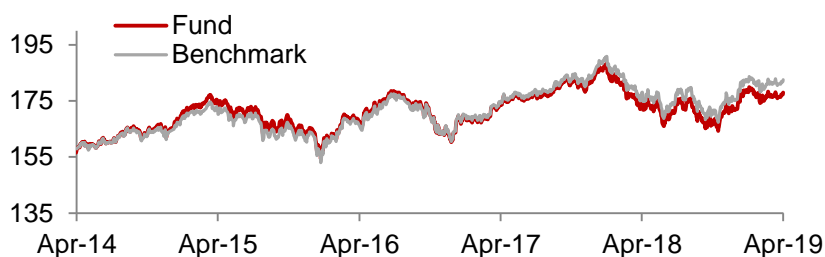

OUTLOOK AND STRATEGY

Market Review. The local equities market inched up by 0.4% month-on-month to 7,952.72 in April with lackluster volumes due to a number of non-working holidays. The market also traded at a wide range of 7,700 and 8,000 as investors looked for direction with barely any significant catalysts in the period.

However, the property sector surged particularly ALI and SMPH on expectations of lower interest rate environment coupled with the continued strength in their residential segments. Meanwhile, activity slowed by 0.8% to US\$125.5 million for April. In terms of flows, foreigners continued to be net buyers at US\$194 million but this was bloated by the AC bond conversion to ALI shares.

Economic news for the month of April: 1) March inflation print that slowed to 3.3% from previous month's 3.8% on moderation of food & non-alcoholic beverages prices. 2) The President finally signed the National Budget for 2019 with some of provisions vetoed amounting to US\$1.8 billion. 3) A surprise credit upgrade from global debt watcher, Standard and Poor's, that saw the Philippine's score move from BBB to BBB+.

Top index gainers for the month include ALI (+9.02%), SCC (+8.66%), and TEL (+6.96%). Meanwhile, worst performing index names were PGOLD (-12.89%), GLO (-8.15%), and AGI (-7.43%).

Fund Performance. The fund rose 0.46% in April, outperforming its benchmark by 6 basis points. Year-to-date, it underperformed the benchmark by 57 basis point with a return of 3.44%.

Fund Strategy. We still continue to adopt a defensive strategy with the market. We look to buy on dips at appropriate levels in the upcoming MSCI rebalancing that is expected have outflows in the market. Tactically, we will look to reduce some property names that have outperformed and shift towards conglomerates that offer value.

- (b) Primarily medium term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
