#### INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

#### CLIENT SUITABILITY

The BPI Balanced Fund is suitable for investors who:

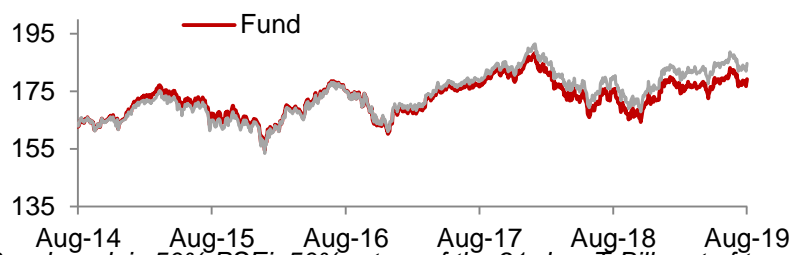

## OUTLOOK AND STRATEGY

**Market Review.** The Philippine Stock Exchange Index (PSEi) gave up 0.80% for the month of August led by the decline on the property sector. Sell-off ensued following news that PAGCOR stated that it will stop accepting any new POGO applications after the Chinese government advised the country to ban online gambling. On the global front, escalations of the US-China Trade War and the unrest in Hong Kong exacerbated market sentiment. Volumes picked up at Php7.17 billion owing to a slew of rebalancing acts coming from the PSE and MSEi. In terms of flows, foreigners were net buyers at US\$80 million.

Economic news include: 1) GDP growth in 2Q2019 came out at 5.5% - weaker than expected on the back of the delay in the passing of the 2019 budget. 2) CPI slowed to 2.4% in the month of July, slower than 2.7% in June, owing to lower food and non-alcoholic beverages and housing and utilities. The CPI print is well-within the government's range of 2%-4%.

Top index gainers for the month include SECB (+11.78%), JGS (+10.27%), and URC (+8.40%). Meanwhile, worst performing index names were AGI (-18.49%), MEG (-16.18%), and DMC (-10.75%).

**Fund Performance.** The fund returned -0.34% in July, underperforming its benchmark by 4 basis points. Year-to-date, it underperformed the benchmark by 59 basis point with a return of 4.20%.

**Fund Strategy.** We expect the market to trade range-bound as we keep an eye on the PSEi's ability to hold above the long-term support. Also, we will take advantage of the volatility dictated by external factors such as US-China Trade War and FTSE rebalancing. Theme-wise, we favor defensive stocks in the meantime given the declining yield environment.

- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
