#### INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

#### CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. The BPI Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

#### KEY RISKS AND RISK MANAGEMENT

<b>Interest Rate Risk:</b>	Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. 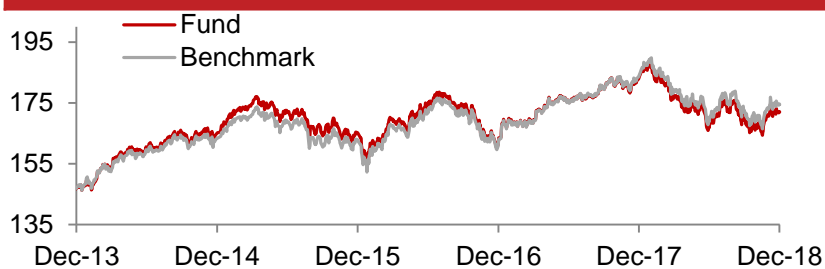

## OUTLOOK AND STRATEGY

**Market Review.** The Philippine Stock Exchange (PSEi) continued its ascent in December, rising 1.3% month-on-month to close the year at 7,466 and paring the year-to-date loss to 12.8%. Aside from year-end rebalancing by investors, the market was positively impacted by a lower-than-expected November inflation print (6.0% yoy vs. expectations of 6.3%), as well as a higher-than-expected October remittance growth figure (8.7% yoy). For its last meeting of the year, the Bangko Sentral ng Pilipinas (BSP) held policy rates constant and cut its 2019 and 2020 inflation forecasts (3.18% from 3.50% and 3.04% from 3.30%, respectively). Foreigners continued to be net sellers for the month, with portfolio outflows amounting to PHP725.4 million or USD13.8 million in December.

Top gainers for December include JGS (+15.6%), FGEN (+12.8%), and AP (+10.8%), with the largest month-on-month detractors being SMC (-15.9%), SCC (-12.0%), and PCOR (-6.0%). Year-to-date, SMC (+31.7%), FGEN (+17.5%), and MER (+15.64%) were the leaders while SECB (-38.4%), SCC (-37.4%), and MPI (-32.3%) declined the most.

**Fund Performance.** The fund rose 0.80% in December, underperforming its benchmark by 4 basis points. Year-to-date, it underperformed the benchmark by 145 basis point with a return of -6.39%.

**Fund Strategy.** We are looking to accumulate preferred names on market dips to keep our strategic weight on equities in the long term—this is on the back of our expectations of sustained economic growth, continued earnings expansion, and stabilizing global growth. We continue to like liquid names with good earnings visibility, as well as names that would benefit from this year's election story.

- (b) Primarily medium term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
