INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk: Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. Factors/ events that may lead to a rise interest rates include adverse market conditions, issuer-specific factors/ events and/ or negative developments in domestic political and economic conditions.

Equity Price Risk: Investors are exposed to adverse changes in the prices of stocks listed in the Philippine Stock Exchange, which may be brought about by adverse stock market conditions, unfavorable company earnings and valuations and/ or negative developments in domestic and global political and economic conditions.

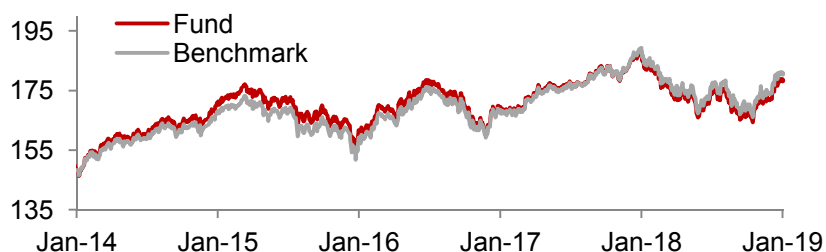

RELATED PARTY TRANSACTIONS*

OUTLOOK AND STRATEGY

Market Review. The PSEi kicked off the year on a high note, rising by 7.25% in January to 8,007.48 following a surge of inflows. This was a result of the shift from Developed Markets to Emerging Markets. The rally came with relatively strong volume at US\$166 million.

A myriad of significant market news occurred in the first month of the year. One of which is the pair of placements in AC (US\$225million at a discounted price of P900 per share) and PGOLD (US\$90 million top-up with the price of P45 per share). Secondly, 4QGDP came out at 6.1% YoY which brought the FY2018 figure to 6.2% driven by consumption, government spending while investments slowed down. Third is the CPI Inflation for the month of December which registered at 5.1%, lower than consensus estimates of 5.6%, as food prices have started to normalize and oil prices declined.

In terms of foreign flows, a huge chunk of inflow welcomed the first month of the year at US\$356 million.

Top index gainers for the month include AEV (+16.82%), URC (+16.61%), and JGS (+16.07%). Meanwhile, worst performing index names were LTG (-6.63%), MER (-3.74%), and BPI (-3.19%).

Fund Performance. The fund rose 3.70% in January, underperforming its benchmark by 14 basis points. Year-to-date, it underperformed the benchmark by 14 basis point with a return of 3.70%.

Fund Strategy. Given the recent run-up in equities, we look to increase our exposure at any point of market weakness. In terms of style, we retain our preference in banks, consumer, properties and selected large cap names.

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- (a) Shares of Stock of selected corporations which are already listed or being offered publicly and soon to be listed in major capital markets.
- (b) Primarily medium term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
