INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk:	Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. Factors/ events that may lead to a rise interest rates include adverse market conditions, issuer-specific factors/ events and/ or negative developments in domestic political and economic conditions.
Equity Price Risk:	Investors are exposed to adverse changes in the prices of stocks listed in the Philippine Stock Exchange, which may be brought about by adverse stock market conditions, unfavorable company earnings and valuations and/ or negative developments in domestic and global political and economic conditions.

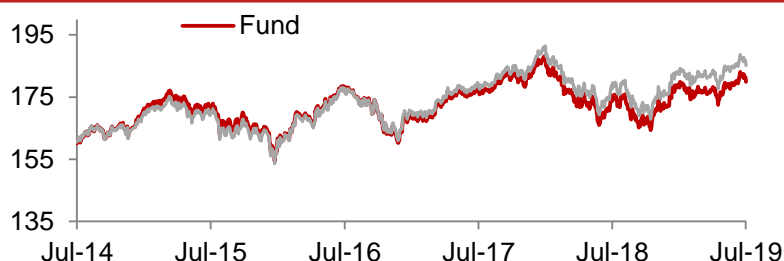

OUTLOOK AND STRATEGY

Market Review. The local bourse index barely moved an inch as gains (which prompted to market to rise at an intra-day high of 8,419.59) fueled by optimism of rate cuts earlier in the month, easing trade tensions between the US and China, as well as catch-up spending by the government, were pared by profit-taking. The PSEi climbed by 0.6% month on month in July to 8,045.80. Volumes were thin yet again with an average daily turnover of Php5.97 billion compared to Php6.28 billion recorded in the prior period. In terms of flows, foreigners were net buyers US\$80 million.

Economic news for the month include: 1) 2Q corporate earnings commenced with SMPH kicking it off with a strong performance as profit jumped 16% YoY to Php10.5 billion. 2) CPI inflation for the month of June eased to 2.7% from 3.2% in May which provides the BSP more reason to cut policy rates further.

Top index gainers for the month include BPI (+14.65%), SECB (+7.35%), and RRHI (+7.16%). Meanwhile, worst performing index names were TEL (-10.85%), JFC (-8.09%), and ICT (-7.79%).

Fund Performance. The fund returned 0.64% in July, outperforming its benchmark by 20 basis points. Year-to-date, it underperformed the benchmark by 57 basis point with a return of 4.55%.

Fund Strategy. August is expected to be volatile as trading volumes have been historically thin. We will take advantage of the opportunity to increase exposure on market dips as we are long-term positive on equities given the following scenarios: a.) Potential policy rate cut by the US Fed in 2nd half 2019; b.) Lower domestic rates on the back of BSP monetary easing; and c.) Expected improvement in GDP growth (>6%) driven by resumption in government spending for infrastructure projects. d.) PH Corporate earnings recovery on lower inflation and government stimulus.

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- (a) Shares of Stock of selected corporations which are already listed or being offered publicly and soon to be listed in major capital markets.
- (b) Primarily medium term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
