INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk:	Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. Factors/ events that may lead to a rise interest rates include adverse market conditions, issuer-specific factors/ events and/ or negative developments in domestic political and economic conditions.

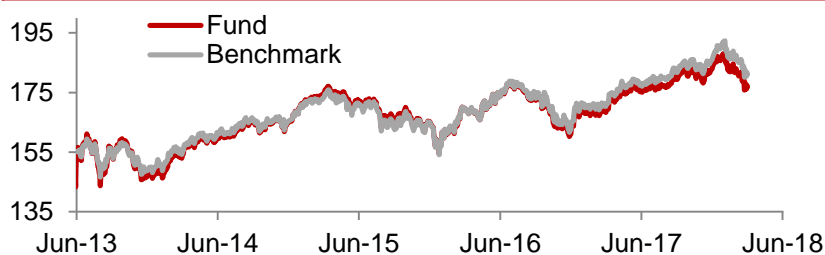

OUTLOOK AND STRATEGY

Market Review. The Philippine Stock Exchange (PSEi) continued to fall in June, falling 4.05% month-on-month and 15.95% year-to-date to close the first half of the year at 7,194. For the month, the market was adversely affected by risk-off sentiment as trade war concerns re-emerged following reports that the US sought to increase tariffs imposed on China. Despite the Bangko Sentral ng Pilipinas (BSP) hiking rates this month by 25 bps, the second time this year, concerns on the local currency and inflation continued to weigh in on foreign investors' decisions. Foreigners continued to be net sellers for the month, with portfolio outflows amounting to PHP13 billion or USD253 million in June.

Top gainers for June include MER (+10.2%), SCC (+5.9%), and SECB (+2.6%), with the largest month-on-month detractors being RLC (-15.7%), AGI (-12.6%), and LTG (-12.5%). Year-to-date, SMC (+23.6%), MER (+8.2%), and JFC (+4.0%) were the leaders while MPI (-32.9%), JGS (-30.7%), and GTCAP (-29.6%) declined the most.

Fund Performance. The fund fell 1.97% in June, underperforming its benchmark by 5 basis points. It underperformed the benchmark on a year-to-date basis by 108 basis points with a return of -8.43%.

Fund Strategy. Amid the persisting volatility, we remain selective and defensive while keeping our strategic weight on equities in the long term—this is on the back of our expectations of sustained economic growth, continued earnings expansion, and stabilizing global growth picture. Further, we still prefer large cap, highly liquid names; and take advantage of dips in the market to add to our positions.

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- (a) Shares of Stock of selected corporations which are already listed or being offered publicly and soon to be listed in major capital markets.
- (b) Primarily medium term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
