INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk: Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. Factors/ events that may lead to a rise interest rates include adverse market conditions, issuer-specific factors/ events and/ or negative developments in domestic political and economic conditions.

Equity Price Risk: Investors are exposed to adverse changes in the prices of stocks listed in the Philippine Stock Exchange, which may be brought about by adverse stock market conditions, unfavorable company earnings and valuations and/ or negative developments in domestic and global political and economic conditions.

Liquidity Risk: Investors are exposed to the risk of loss due to the fund's inability to convert fixed income and equity security holdings to cash immediately or in instances where conversion to cash is possible but at a highly disadvantageous price due to limited buyers/ sellers in the market, low trading volumes or market disruptions, among other reasons/ factors.

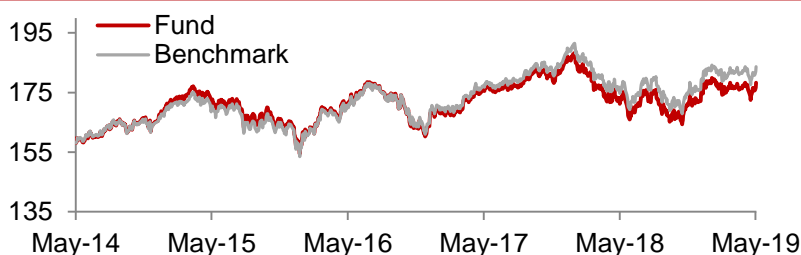

OUTLOOK AND STRATEGY

Market Review. The local equities market performed flattish on the month of May, rising by 0.2% to close at 7,970.02. It was a month full of market-moving events led by the MSCI Rebalancing which had its first tranche of Philippine sell-off in response to the accommodation of China A-Shares.

Moreover, tensions continue to flare between US and China as US President Donald Trump increased tariffs to go along with imposition of a restriction on China-led Huawei. In terms of flows, foreigners continued to be sellers, registering a whopping US\$270million.

Other economic news for the month include: 1) 1Q 2019 GDP came out at the lowest pace in the past 4 years, registering 5.6% vs consensus of 6%, mainly dragged by the delayed enactment of the 2019 national budget. 2) Inflation was steady at 3% for the month of April. 3) Results for the 1Q 2019 Corporate Earnings was a mixed bag. 47% of PSE stocks however ended up behind expectations.

Top index gainers for the month include GLO (+21.91%), TEL (+9.76%), and URC (+9.65%). Meanwhile, worst performing index names were SCC (-7.76%), BLOOM (-7.06%), and LTG (-6.86%).

Fund Performance. The fund rose 0.20% in May, outperforming its benchmark by 9 basis points. Year-to-date, it underperformed the benchmark by 64 basis point with a return of 3.64%.

Fund Strategy. Given the volatility in the market in the short-run, we will continue to be nimble in taking price advantages. We look to buy on dips at appropriate levels. Tactically, we will look to reduce some property names that have outperformed and shift towards conglomerates that offer value. Sector-wise, we retain our preference in property, banking and consumer.

- (b) Primarily medium term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
