INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

KEY RISKS AND RISK MANAGEMENT

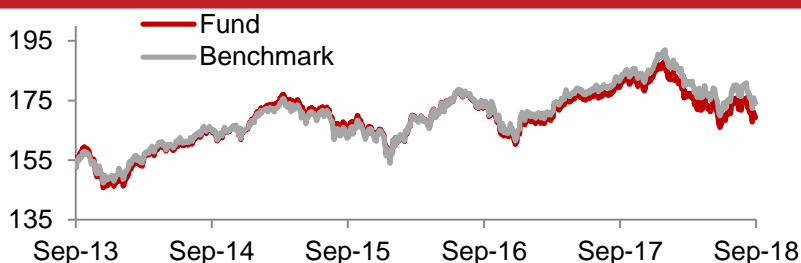

RELATED PARTY TRANSACTIONS*

OUTLOOK AND STRATEGY

Market Review. The Philippine Stock Exchange (PSEi) continued to fall in September, falling 7.37% month-on-month and 14.97% year-to-date to close the third quarter of 2018 at 7,277. For the month, the market was adversely affected by risk-off sentiment due to the continued rise in inflation (6.4% yoy in August vs. expectations of 5.9%), as well as the widening trade deficit (July figure at -\$3.5 billion). To mitigate inflation, the Bangko Sentral ng Pilipinas (BSP) hiked rates this month by 50 bps. Foreigners continued to be net sellers for the month, with portfolio outflows amounting to PHP11.5 billion or USD212.6 million in September.

Top gainers for September include GLO (+4.0%), URC (+3.6%), and ICT (+0.5%), with the largest month-on-month detractors being SECB (-20.8%), LTG (-16.3%), and MPI (-12.8%). Year-to-date, SMC (+51.9%), GLO (+15.8%), and MER (+3.5%) were the leaders while SECB (-38.8%), GTCAP (-34.3%), and AEV (-33.8%) declined the most.

Fund Performance. The fund fell 5.65% in September, outperforming its benchmark by 1 basis point. It underperformed the benchmark on a year-to-date basis by 129 basis points with a return of -7.82%.

Fund Strategy. We remain selective and defensive in the short term as volatility is expected to persist due to listless trading over the last quarter of the year. We are looking to accumulate preferred names on market dips to keep our strategic weight on equities in the long term—this is on the back of our expectations of sustained economic growth, continued earnings expansion, and stabilizing global growth. We continue to like liquid names with good earnings visibility

- (a) Shares of Stock of selected corporations which are already listed or being offered publicly and soon to be listed in major capital markets.
- (b) Primarily medium term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
