INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Invest Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

Interest Rate Risk:	Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. 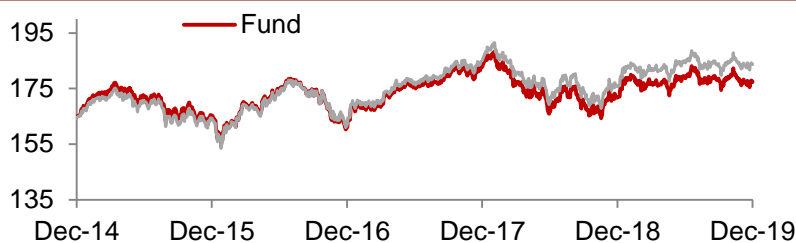

RELATED PARTY TRANSACTIONS*

The Fund has transactions and outstanding investments including deposit, investments in the share/s of stock, and/or debt issuances of the following companies related to the BPI Asset Management and Trust Corporation (BPI AMTC):

OUTLOOK AND STRATEGY

Market Review. The Philippine Stock Exchange Index was able to close out the year a tad higher despite the presence of strong internal and external volatility. The PSEi rose by 1% month-on-month to 7,815.23 with average value turnover registering at US\$139.4 million.

On the domestic front, the market was rocked by water utilities issue where the government went after Maynilad and Manila Water, concerning some onerous items in the water concession contract. The former stated that it would revoke the concession extension the utilities have until 2037.

On the other side of the coin, the geopolitical tensions were rampant from the ever-evolving US-China Trade War, Hong Kong uprising to the India protest. Also, index rebalancing related activities such as FTSE rebalancing and MSCI (inclusion of Saudi Aramco and China A-Shares) further exacerbated the sell-off.

However, the market got resuscitated as optimism arose following the progress of Phase 1 of the deal between US and China. In terms of flows, foreigners continue to be net sellers at US\$173 million which stretched the selling to US\$230 million for the year.

In terms of individual stock performance, gains were led by JFC (+9.2%), GLO (+6.7%) and RRHI (+6.4%). Laggards for the month include MPI (-19.1%), MEG (-12.1%) and TEL (-8.5%).

Fund Performance. The fund returned 0.33% in December, underperforming its benchmark by 26 basis points. Year-to-date, it underperformed the benchmark by 103 basis points with a return of 3.08%.

Fund Strategy. We remain cautious in the equities market given regulatory landscape and inflation risks. However, upside remains on expected PH earnings growth and global risk asset flows to favor the emerging markets. We look to buy on dips especially on sectors that will benefit from monetary policy actions (banking and property)

- (a) Shares of Stock of selected corporations which are already listed or being offered publicly and soon to be listed in major capital markets.
- (b) Primarily medium term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
