INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Invest Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk:	Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. Factors/ events that may lead to a rise interest rates include adverse market conditions, issuer-specific factors/ events and/ or negative developments in domestic political and economic conditions.

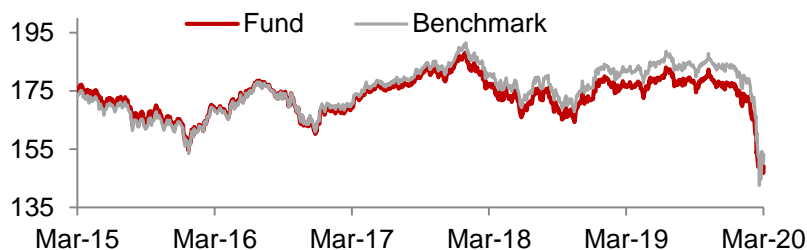

OUTLOOK AND STRATEGY

Market Review. The Philippine Stock Exchange Index (PSEi) suffered a severe blow as the Corona virus pandemic has become more lethal with cases and deaths mounting world-wide. The local government has responded by imposing a Luzon-wide enhanced community quarantine. The PSEi sank by a whopping 21.6% for the month of March to close at 5,321.23. Volume was a tad heavier compared to the previous month with average turnover registering at US\$137 million. Foreigners were net sellers at US\$303 million which was the 5th straight month of outflows.

Macroeconomic news for the month include: 1) Inflation slowed to 2.6% in February due to lower prices of gas, electricity and other fuels; and transport. 2) The Monetary Board of the Bangko Sentral ng Pilipinas (BSP) cut the overnight reverse repurchase (RRP) by 50 basis points to 3.25% in response to the COVID-19 outbreak. 3) OFW remittances climbed 6.6% to US\$2.65 billion in January due to land-based remittances from Asia (+26% YoY) and USA (+15% YoY).

In terms of individual stock performance, the main advancers were defensives TEL (+14.04%) and GLO (+8.49) while the biggest declines SCC (-43.30%), GTCAP (-42.76%) and JFC (-37.41%).

Fund Performance. The fund returned -9.92% in March, outperforming its benchmark by 78 basis points. Year-to-date, it underperformed the benchmark by 25 basis points with a return of -15.88%.

Fund Strategy. Given the heightened uncertainties that will drive volatility with the PSEi, we opt to maintain our defensive stance and raise cash on rallies.

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- (a) Shares of Stock of selected corporations which are already listed or being offered publicly and soon to be listed in major capital markets.
- (b) Primarily medium term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
