INVESTMENT OBJECTIVE AND STRATEGY

The Fund intends to achieve for its participants capital appreciation and income derived from a diversified mix of preferred stocks and fixed income securities primarily issued by Philippine corporations. The Fund aims to provide returns in excess of the return of the BPI Philippine Corporate Bond Index.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI PERA Corporate Income Fund is suitable only for investors who:

- Are classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years.

KEY RISKS AND RISK MANAGEMENT

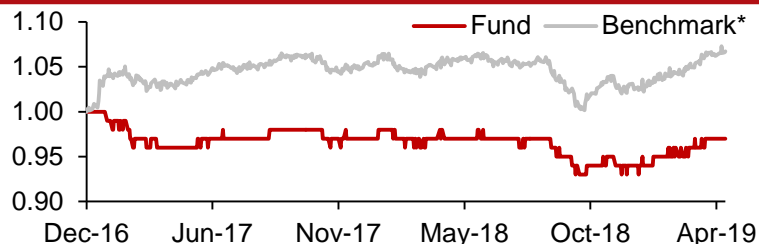

RELATED PARTY TRANSACTIONS

The Fund has transactions and outstanding investments including deposits, investment in the share/s of stocks, and/or debt issuances of the following companies related to the BPI Asset Management and Trust Corporation (BPI AMTC): Ayala Corp.– PHP 0.31mn, Bank of the Philippine Islands, Inc. – PHP0.49mn, Globe Telecommunications, Inc. - PHP 0.07mn and Ayala Land, Inc. – PHP 0.09mn

Investments in the said outlets were approved by the BPI AMTC's Board of Directors. Likewise, all related party transactions are conducted on an arm's length and best execution basis and within established limits.

OUTLOOK AND STRATEGY

Market Review. The BPI Government Bond Index fell slightly by 0.87% in April as yields rose by an average of 19.3 basis points across the curve. Peso-denominated government bonds were less actively traded this month compared to March, averaging Php15.3 billion per day. Trades were observed across the curve, especially on the recently-issued RTB5-12 and FXTN20-23.

The Bureau of the Treasury scheduled two FXTN auctions for April, a 10-year paper and a 20-year paper. The first auction was a re-issuance of the 10-year FXTN10-64, awarded at an average yield of 5.954% compared to the previous average of 6.196% during its last reissuance in March. The auction saw healthy demand with Php46.47 billion in total bids tendered. The next auction was a re-issuance of the 20-year FXTN20-23. Demand was likewise quite healthy, with bids totaling Php31.72 billion compared to the Php20 billion offer size. However, the government fully rejected all bids as the yield would have risen to 6.215% if fully awarded, roughly 20 basis points higher than where it was trading at the secondary market.

Inflation for the month of March eased further to 3.3%, well within the central bank's targeted band of 2-4% for the year. The main driver of the yearly increase in prices was still the food and non-alcoholic beverages category. BSP Governor Benjamin Diokno stated that while he saw room for policy rate easing and a reduction in the reserve requirement ratio (RRR), the monetary board would need more data to determine the appropriate monetary policy response moving forward.

Fund Performance. The Fund outperformed its benchmark by 23 bps in April.

Fund Strategy. The Fund will continue to invest in a diversified mix of securities primarily issued by Philippine corporations.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily tradable fixed-income instruments issued or guaranteed by Philippine corporations; marketable instruments that are traded in an organized exchange; fixed-income instruments issued or guaranteed by the Philippine government or the BSP; investment outlets/ categories the BSP allow. Provided, that, a financial instrument is regarded as tradable if quoted two-way prices are readily available and regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- b) Primarily tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund or any such instrument as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X 410.12 (a) of the Manual of Regulations for Banks.
- c) Shares of preferred stock of selected corporations which are already listed or being offered publicly and soon to be listed in the Philippine stock market.
- d) Bank deposits or tradable debt instruments issued by the BSP.
- e) Such other investments allowed under regulations issued by the BSP.
