**INVESTMENT OBJECTIVE AND STRATEGY**

The Fund intends to achieve for its participants capital appreciation and income derived from a diversified mix of preferred stocks and fixed income securities primarily issued by Philippine corporations. The Fund aims to provide returns in excess of the return of the BPI Philippine Corporate Bond Index.

**CLIENT SUITABILITY**

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI PERA Corporate Income Fund is suitable only for investors who:

- Are classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years.

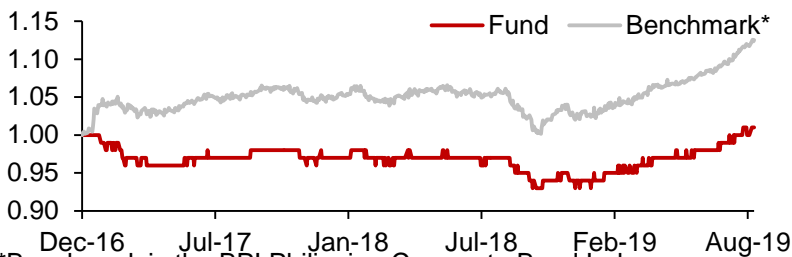

### RELATED PARTY TRANSACTIONS

The Fund has transactions and outstanding investments including deposits, investment in the share/s of stocks, and/or debt issuances of the following companies related to the BPI Asset Management and Trust Corporation (BPI AMTC): Ayala Corp. – PHP 0.33mn, Bank of the Philippine Islands, Inc. – PHP0.59mn, Globe Telecommunications, Inc. - PHP 0.07mn and Ayala Land, Inc. – PHP 0.10mn

Investments in the said outlets were approved by the BPI AMTC's Board of Directors. Likewise, all related party transactions are conducted on an arm's length and best execution basis and within established limits.

## OUTLOOK AND STRATEGY

**Market Review.** The BPI Government Bond Index rose 1.96% in August, with yields of benchmark government securities falling an average of 37.5 basis points (bps). Daily trading volume was healthy, averaging PHP35.0bn, with the 5-year RTB5-12 and 7-year FXTN7-62 securities seeing the heaviest trading volumes over the month.

The Bureau of the Treasury (BTr) held two FXTN auctions in August, reissuances of FXTNs 10-64 and 3-24. Both reissuances saw strong demand, being 2.25x oversubscribed. The 10-year reissuance had an issue size of PHP20bn and was awarded at an average yield of 4.196%, 145 bps below the yield it was awarded at in the previous auction of FXTN10-64 in May of this year. The 3-year paper also had an issue size of PHP20bn and was awarded at an average yield of 3.961%, 84 bps below the average yield the security was awarded at in the previous auction last month.

In the local space, inflation for the month of July came in below market expectations, rising 2.4% year-on-year, still within the central bank's target range of 2-4%. The minimal increase for the month reflected the slower annual rate posted by the food and non-alcoholic beverages component of the index. The 2nd quarter GDP growth figure was likewise released, with the economy expanding 5.5% year-on-year. This was lower than consensus estimates. Bulk of the drag in growth came from weak public consumption numbers and a contraction in overall investments. Benign inflation, coupled with weaker growth, prompted Central Bank Governor Benjamin Diokno to once again hint at policy easing. Nevertheless, monetary authorities will continue to vigilantly monitor economic data so as to determine an appropriate policy response moving forward.

**Fund Performance.** The Fund underperformed its benchmark by 69 bps in August.

**Fund Strategy.** The Fund will continue to invest in a diversified mix of securities primarily issued by Philippine corporations.

## LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily tradable fixed-income instruments issued or guaranteed by Philippine corporations; marketable instruments that are traded in an organized exchange; fixed-income instruments issued or guaranteed by the Philippine government or the BSP; investment outlets/ categories the BSP allow. Provided, that, a financial instrument is regarded as tradable if quoted two-way prices are readily available and regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- b) Primarily tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund or any such instrument as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X 410.12 (a) of the Manual of Regulations for Banks.
- c) Shares of preferred stock of selected corporations which are already listed or being offered publicly and soon to be listed in the Philippine stock market.
- d) Bank deposits or tradable debt instruments issued by the BSP.
- e) Such other investments allowed under regulations issued by the BSP.
