**INVESTMENT OBJECTIVE AND STRATEGY**

The Fund intends to achieve for its participants capital appreciation and income derived from a diversified mix of preferred stocks and fixed income securities primarily issued by Philippine corporations. The Fund aims to provide returns in excess of the return of the BPI Philippine Corporate Bond Index.

**CLIENT SUITABILITY**

Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI PERA Corporate Income Fund is suitable only for investors who:

- Are classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years.

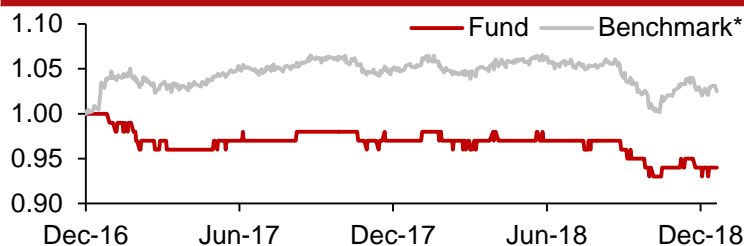

### RELATED PARTY TRANSACTIONS

The Fund has transactions and outstanding investments including deposits, investment in the share/s of stocks, and/or debt issuances of the following companies related to the BPI Asset Management and Trust Corporation (BPI AMTC): Ayala Corp. – PHP 0.29mn, Bank of the Philippine Islands, Inc. – PHP0.10mn, Globe Telecommunications, Inc. - PHP 0.07mn and Ayala Land, Inc. – PHP 0.34mn

Investments in the said outlets were approved by the BPI AMTC's Board of Directors. Likewise, all related party transactions are conducted on an arm's length and best execution basis and within established limits.

## OUTLOOK AND STRATEGY

**Market Review.** The BPI Government Bond Index rose by 0.52% in December even as yields rose by an average of 7.38 basis points across the curve. Peso-denominated government bonds were less actively traded this month compared to November. Trades were observed on the short-dated Treasury Bills, as well as more recently issued securities such as the 5-year FXTN 5-75 and the 7-year FXTN 7-61.

The Bureau of the Treasury held two FXTN auctions for the month of December. The first was a re-issuance of the 10-year FXTN 10-63, awarded at an average yield of 6.975%, 106 basis points lower than where it was awarded in a similar auction held November. Bids totaled Php49.4 billion, compared to the initial offer of Php15 billion. Strong demand prompted the BTr to open a tap issuance, which resulted in a total of Php30 billion worth of FXTN 10-63 being awarded to the market. The second auction was a FXTN 7-61 reissuance which saw slightly weaker demand, as the BTr's tap only saw Php2 billion awarded. Average yield was at 7.090%, slightly higher than the 6.974% average seen in November.

Inflation for the month of November came in at 6%, slower than the figure posted in October. The decline was attributed to easing global oil prices and food price inflation. Note that persistently high inflation has kept local market players erring on the side of caution, especially with the Bangko Sentral ng Pilipinas (BSP) retaining a hawkish tone amid rising price pressures. However, reports that inflation may have already peaked calmed the market somewhat, lending support to local yields. The BSP has its raised policy rates by 150 basis points in total since the beginning of the year. During its monetary policy meeting in late December, the BSP held rates steady but mentioned that it would continue to vigilantly monitor economic data moving forward.

**Fund Performance.** The Fund outperformed its benchmark by 41 bps in December.

**Fund Strategy.** The Fund will continue to invest in a diversified mix of securities primarily issued by Philippine corporations.

## LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily tradable fixed-income instruments issued or guaranteed by Philippine corporations; marketable instruments that are traded in an organized exchange; fixed-income instruments issued or guaranteed by the Philippine government or the BSP; investment outlets/ categories the BSP allow. Provided, that, a financial instrument is regarded as tradable if quoted two-way prices are readily available and regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- b) Primarily tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund or any such instrument as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X 410.12 (a) of the Manual of Regulations for Banks.
- c) Shares of preferred stock of selected corporations which are already listed or being offered publicly and soon to be listed in the Philippine stock market.
- d) Bank deposits or tradable debt instruments issued by the BSP.
- e) Such other investments allowed under regulations issued by the BSP.
