INVESTMENT OBJECTIVE AND STRATEGY

The Fund intends to achieve for its participants capital appreciation and income derived from a diversified mix of preferred stocks and fixed income securities primarily issued by Philippine corporations. The Fund aims to provide returns in excess of the return of the BPI Philippine Corporate Bond Index.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI PERA Corporate Income Fund is suitable only for investors who:

- Are classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years.

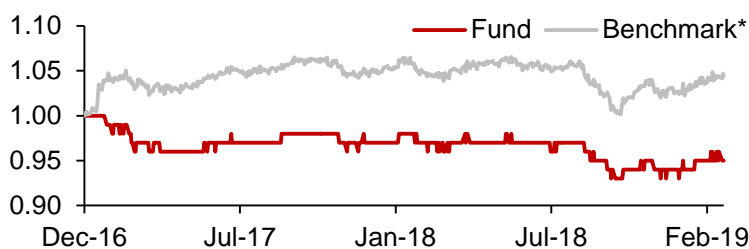

RELATED PARTY TRANSACTIONS

The Fund has transactions and outstanding investments including deposits, investment in the share/s of stocks, and/or debt issuances of the following companies related to the BPI Asset Management and Trust Corporation (BPI AMTC): Ayala Corp.– PHP 0.30mn, Bank of the Philippine Islands, Inc. – PHP0.12mn, Globe Telecommunications, Inc. - PHP 0.07mn and Ayala Land, Inc. – PHP 0.34mn

Investments in the said outlets were approved by the BPI AMTC's Board of Directors. Likewise, all related party transactions are conducted on an arm's length and best execution basis and within established limits.

OUTLOOK AND STRATEGY

Market Review. The BPI Government Bond Index rose by 0.47% in February as yields fell by an average of 2.12 basis points across the curve. Peso-denominated government bonds were more actively traded this month compared to January. Trades were observed across the curve, especially on the short-dated Treasury Bills and FXTN7-56, as well as more recently issued securities such as the 10-year FXTN 10-64 and the 20-year FXTN 20-23.

The Bureau of the Treasury initially scheduled two FXTN auctions for February, but cancelled the second one at the latter part of the month to give way to its new Retail Treasury Bond (RTB) Issuance. The first auction was a new issuance of a 7-year FXTN 7-62, awarded at a coupon of 6.250%, with an average yield of 6.087%. The auction saw strong demand with Php66.92 billion in total bids tendered, prompting the BTr to open a tap facility for Php10 billion.

On February 26, the government held a 5-year RTB auction with an initial offer size of Php30 billion. The paper was awarded at a coupon of 6.25%, with the initial awarded size at Php113.7 billion. Offer period was scheduled from February 26 to March 8, 2019, while issue date will be on March 12, 2019.

Inflation for the month of January slowed to 4.4%, slightly lower than consensus estimates and much lower than the 5.1% print in December. The main driver of the monthly increase in prices was the food and non-alcoholic beverages category. Easing inflation contributed to positive sentiment in the market, and thus bond prices were supported throughout the month. On the 24th of February, it was announced that BSP Governor Nestor Espenilla had passed following a year-long battle with tongue cancer. BSP Deputy Governor Almasara Cyd Tuano-Amador was designated as the BSP officer-in-charge until such time that a successor was appointed.

Fund Performance. The Fund underperformed its benchmark by 16 bps in February.

Fund Strategy. The Fund will continue to invest in a diversified mix of securities primarily issued by Philippine corporations.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily tradable fixed-income instruments issued or guaranteed by Philippine corporations; marketable instruments that are traded in an organized exchange; fixed-income instruments issued or guaranteed by the Philippine government or the BSP; investment outlets/ categories the BSP allow. Provided, that, a financial instrument is regarded as tradable if quoted two-way prices are readily available and regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- b) Primarily tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund or any such instrument as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X 410.12 (a) of the Manual of Regulations for Banks.
- c) Shares of preferred stock of selected corporations which are already listed or being offered publicly and soon to be listed in the Philippine stock market.
- d) Bank deposits or tradable debt instruments issued by the BSP.
- e) Such other investments allowed under regulations issued by the BSP.
