INVESTMENT OBJECTIVE AND STRATEGY

The Fund intends to achieve for its participants capital appreciation and income derived from a diversified mix of preferred stocks and fixed income securities primarily issued by Philippine corporations. The Fund aims to provide returns in excess of the return of the BPI Philippine Corporate Bond Index.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI PERA Corporate Income Fund is suitable only for investors who:

- Are classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years.

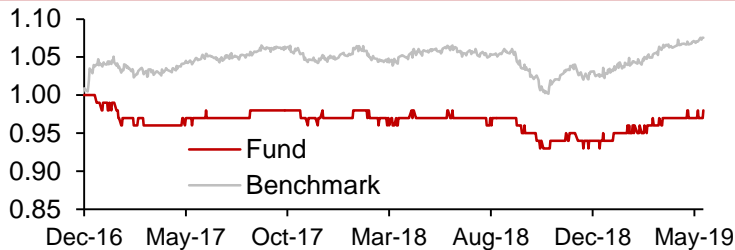

RELATED PARTY TRANSACTIONS

The Fund has transactions and outstanding investments including deposits, investment in the share/s of stocks, and/or debt issuances of the following companies related to the BPI Asset Management and Trust Corporation (BPI AMTC): Ayala Corp. – PHP 0.31mn, Bank of the Philippine Islands, Inc. – PHP0.49mn, Globe Telecommunications, Inc. - PHP 0.07mn and Ayala Land, Inc. – PHP 0.09mn

Investments in the said outlets were approved by the BPI AMTC's Board of Directors. Likewise, all related party transactions are conducted on an arm's length and best execution basis and within established limits.

OUTLOOK AND STRATEGY

Market Review. The BPI Government Bond Index rose 2.05% in May, with yields of benchmark government securities falling an average of 36.3 basis points (bps). Daily trading volume was substantial, averaging PHP26.7bn, with particularly heavy trading of the recently-issued RTB5-12 and FXTN7-62 securities.

The Bureau of the Treasury (BTr) held two FXTN auctions in May. The first was a reissuance of the 7-year FXTN7-62, which saw strong demand (PHP51.278bn tendered; 2.56x oversubscribed). The security was awarded at an average yield of 5.743%, below the previous average of 5.934% in its reissuance last March. The second auction was a reissuance of the 10-year FXTN10-64, which the market also received well (PHP65.84bn tendered; 3.29x oversubscribed). The security was awarded at an average yield of 5.644%, 31 bps below the yield it was awarded at in its last reissuance in April.

Inflation for the month of April continued to ease, falling to 3% year-on-year, within the central bank's target range of 2-4%. Food disinflation (driven by lower rice and fish prices) and a lower fiscal impulse from the government (due to a delay in the passage of the budget bill) helped offset higher global fuel prices, helping inflation moderate. With the first-quarter Philippine GDP figure coming in at 5.6% and amid slowing inflation, the Bangko Sentral ng Pilipinas saw fit to cut the policy rate by 25 bps, and announced cuts to the Reserve Requirement Ratio (RRR) for Universal and Commercial Banks totaling 200 bps (over 3 tranches—100 bps on 31 May and 50 bps to follow in both June and July). Moving forward, monetary authorities will continue to vigilantly monitor economic data so as to determine an appropriate policy response.

Fund Performance. The Fund outperformed its benchmark by 27 bps in May.

Fund Strategy. The Fund will continue to invest in a diversified mix of securities primarily issued by Philippine corporations.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily tradable fixed-income instruments issued or guaranteed by Philippine corporations; marketable instruments that are traded in an organized exchange; fixed-income instruments issued or guaranteed by the Philippine government or the BSP; investment outlets/ categories the BSP allow. Provided, that, a financial instrument is regarded as tradable if quoted two-way prices are readily available and regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- b) Primarily tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund or any such instrument as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X 410.12 (a) of the Manual of Regulations for Banks.
- c) Shares of preferred stock of selected corporations which are already listed or being offered publicly and soon to be listed in the Philippine stock market.
- d) Bank deposits or tradable debt instruments issued by the BSP.
- e) Such other investments allowed under regulations issued by the BSP.
