INVESTMENT OBJECTIVE AND STRATEGY

The Fund intends to achieve for its participants capital appreciation and income derived from a diversified mix of preferred stocks and fixed income securities primarily issued by Philippine corporations. The Fund aims to provide returns in excess of the return of the BPI Philippine Corporate Bond Index.

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI PERA Corporate Income Fund is suitable only for investors who:

- Are classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years.

KEY RISKS AND RISK MANAGEMENT

Interest Rate Risk: Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. Related Party Risk: Risk of any actual or potential conflicts of interest in handling of related party transactions.

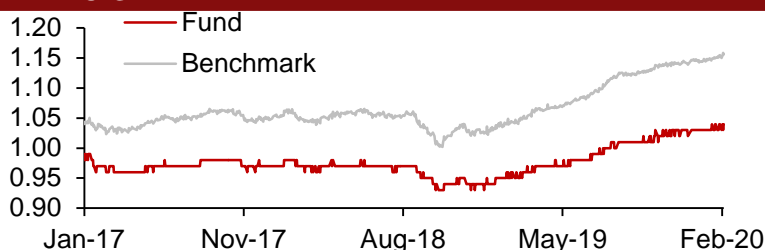

OUTLOOK AND STRATEGY

Market Review. The BPI Government Bond Index returned 1.29% for the month of February, with benchmark government yields falling by an average of 22.5 basis points (bps), led by the long end and belly of the curve. Daily trading volumes picked up from the previous month, averaging PHP37.9bn, with the 9-year FXTN10-64 and 19-year FXTN20-23 securities seeing the heaviest trading volumes over the month.

The Bureau of the Treasury (BTr) held one FXTN auction in February: a PHP30-bn reissuance of the 9-year FXTN10-64. The auction saw healthy demand, with a bid-to-cover ratio of 2.79, and was fully awarded at an average yield of 4.409%, 20.8 bps lower than the average yield rate it was awarded at its last reissuance in November 2019. In the afternoon after the auction, the BTr opened a PHP15-bn tap facility for the security, which was fully awarded at the 4.409% yield, having received PHP47.6bn-worth of interest. Additionally, on February 11, the BTr issued its new 3-year Retail Treasury Bond (RTB3-10), having raised a cumulative PHP311bn from the issuance.

In the local economic space, inflation for the month of January averaged 2.9% year-on-year (versus market expectations of 2.7%). A decline in rice prices was more than offset by a rise in fish and gas prices. Despite the mildly negative inflation surprise, yields were driven downward by a sharp decline in global risk appetite due to the international spread of the coronavirus (COVID-19) and its potential effects on the global supply chain, tourism, and aggregate demand for goods and services. Amid falling local and international growth expectations and within-target inflation, the Bangko Sentral ng Pilipinas (BSP) cut its benchmark policy rate by 25 bps to support market confidence. In a statement made at the end of the month, BSP Governor Benjamin Diokno kept the door open for more policy easing, highlighting his concerns about the impact of the escalating viral outbreak on local economic growth.

Fund Performance. The Fund outperformed its benchmark by 16 bps in February.

Fund Strategy. The Fund will continue to invest in a diversified mix of securities primarily issued by Philippine corporations.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily tradable fixed-income instruments issued or guaranteed by Philippine corporations; marketable instruments that are traded in an organized exchange; fixed-income instruments issued or guaranteed by the Philippine government or the BSP; investment outlets/ categories the BSP allow. Provided, that, a financial instrument is regarded as tradable if quoted two-way prices are readily available and regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- b) Primarily tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund or any such instrument as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X 410.12 (a) of the Manual of Regulations for Banks.
- c) Shares of preferred stock of selected corporations which are already listed or being offered publicly and soon to be listed in the Philippine stock market.
- d) Bank deposits or tradable debt instruments issued by the BSP.
- e) Such other investments allowed under regulations issued by the BSP.
