INVESTMENT OBJECTIVE AND STRATEGY

The Fund intends to achieve for its participants capital appreciation and income derived from a diversified mix of preferred stocks and fixed income securities primarily issued by Philippine corporations. The Fund aims to provide returns in excess of the return of the BPI Philippine Corporate Bond Index.

CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI PERA Corporate Income Fund is suitable only for investors who:

- Are classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk: Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. Related Party Risk: Risk of any actual or potential conflicts of interest in handling of related party transactions.

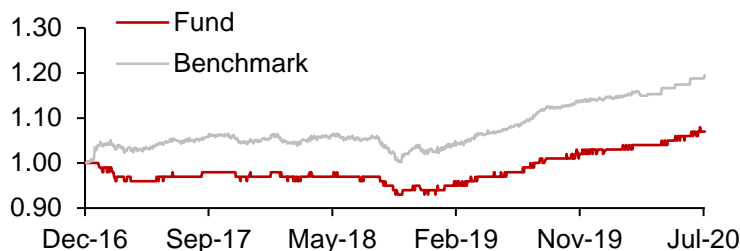

OUTLOOK AND STRATEGY

Market Review. The BPI Government Bond Index returned 0.19% for the month of July with benchmark government yields flat, falling an average of 2 basis points (bps). The yield curve bear steepened, with benchmark yields in the long end of the curve rising with greater magnitude than the decline in short-term benchmark yields. Daily trading volumes rose to PHP22.1bn, with the 2.5-year RTB3-10 and 5-year FXTN10-60 securities seeing the highest trading volumes over the month.

The Bureau of the Treasury (BTr) held one FXTN auction in July: a PHP30bn offering of a new 10-year security, FXTN10-65. The auction saw moderate demand, with bids totaling PHP59.71bn, and was fully awarded at an average yield of 2.759%. In addition, mid-month, the BTr announced and priced a new 5-year retail treasury bond (RTB) that it planned to issue in the upcoming month.

In the local economic space, inflation for the month of June averaged 2.5% year-on-year, above market expectations of 2.2% and rising from May's 2.0% figure. The increase was mainly due to a rise in oil prices, which drove transportation and other related prices higher. Sentiment continued to be driven mainly by developments related to the COVID-19 pandemic, with positive risk sentiment at the start of the month turning negative amidst growing speculation of a potential reimposition of stricter quarantine measures due to a spike in viral transmission. Toward the end of the month, the Bangko Sentral ng Pilipinas (BSP) announced a full percentage-point cut to its reserve requirement ratio (RRR) for thrift banks (bringing the thrift bank RRR to 3%) and rural and cooperative banks (bringing the rural and cooperative bank RRR to 2%), releasing additional liquidity into the economic system. BSP Governor Diokno reiterated the central bank's assessment that inflationary risks would be limited by the effects of the pandemic on domestic and global demand, and that the central bank remained committed to supporting sustainable economic growth using monetary instruments and regulatory relief measures.

Fund Performance. The Fund outperformed its benchmark by 36 bps in July.

Fund Strategy. The Fund will continue to invest in a diversified mix of securities primarily issued by Philippine corporations.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily tradable fixed-income instruments issued or guaranteed by Philippine corporations; marketable instruments that are traded in an organized exchange; fixed-income instruments issued or guaranteed by the Philippine government or the BSP; investment outlets/ categories the BSP allow. Provided, that, a financial instrument is regarded as tradable if quoted two-way prices are readily available and regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- b) Primarily tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund or any such instrument as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X 410.12 (a) of the Manual of Regulations for Banks.
- c) Shares of preferred stock of selected corporations which are already listed or being offered publicly and soon to be listed in the Philippine stock market.
- d) Bank deposits or tradable debt instruments issued by the BSP.
- e) Such other investments allowed under regulations issued by the BSP.
