## INVESTMENT OBJECTIVE AND STRATEGY

The Fund intends to achieve for its participants capital appreciation and income derived from a diversified mix of preferred stocks and fixed income securities primarily issued by Philippine corporations. The Fund aims to provide returns in excess of the return of the BPI Philippine Corporate Bond Index.

## CLIENT SUITABILITY

A client profiling process shall be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI PERA Corporate Income Fund is suitable only for investors who:

- Are classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years.

## KEY RISKS AND RISK MANAGEMENT

**Interest Rate Risk:** Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. **Related Party Risk:** Risk of any actual or potential conflicts of interest in handling of related party transactions.

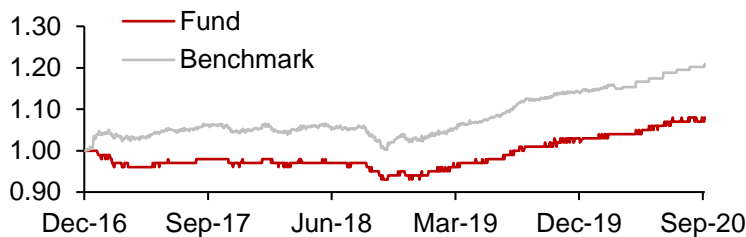

## OUTLOOK AND STRATEGY

**Market Review.** The BPI Government Bond Index returned -1.09% for the month of September with benchmark government yields rising an average of 20 basis points (bps). The yield curve steepened, with benchmark yields in the long end of the curve rising with greater magnitude than short-term benchmark yields. Daily trading volumes fell to PHP18.8bn, with the 5-year RTB5-13 and 5.5-year FXTN7-62 securities seeing the highest trading volumes over the month.

The Bureau of the Treasury (BTr) held two FXTN auctions in September, with PHP30bn on offer for each of a new 3-year FXTN 3-25 security and the 10-year FXTN10-65 security, which was first issued in July. The primary issuance of FXTN3-25 saw strong demand, with bids totaling PHP87.96bn, and was fully awarded at an average yield of 2.279%, with a coupon of 2.375%. The reissuance of FXTN10-65 saw tepid demand, with bids totaling PHP44.51bn, and all bids were rejected by the BTr.

In the local space, August inflation data came in at 2.4% year-on-year, below market expectations of 2.8% and terminating a three month upward streak. Slowing food inflation from high base effects more than offset the continued increase in transport prices, with fares adjusting upward, despite stable oil prices, due to pandemic-related regulations mandating lower maximum passenger capacity in public transportation. As expected, the government extended quarantine restrictions in the capital region to the end of October, and passed a PHP140-bn economic stimulus package that subsidizes sectors negatively affected by the pandemic. Despite unemployment easing from its highs in April, business and consumer confidence surveys indicated dim expectations for the fourth quarter of 2020. Comments from Bangko Sentral ng Pilipinas (BSP) Governor Benjamin E. Diokno reiterated the central bank's accommodative stance, suggesting easy monetary policies may remain in place for the next two years.

**Fund Performance.** The Fund underperformed its benchmark by 53 bps in September.

**Fund Strategy.** The Fund will continue to invest in a diversified mix of securities primarily issued by Philippine corporations.

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily tradable fixed-income instruments issued or guaranteed by Philippine corporations; marketable instruments that are traded in an organized exchange; fixed-income instruments issued or guaranteed by the Philippine government or the BSP; investment outlets/ categories the BSP allow. Provided, that, a financial instrument is regarded as tradable if quoted two-way prices are readily available and regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- b) Primarily tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund or any such instrument as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X 410.12 (a) of the Manual of Regulations for Banks.
- c) Shares of preferred stock of selected corporations which are already listed or being offered publicly and soon to be listed in the Philippine stock market.
- d) Bank deposits or tradable debt instruments issued by the BSP.
- e) Such other investments allowed under regulations issued by the BSP.
