INVESTMENT OBJECTIVE AND STRATEGY

The Fund intends to achieve for its participants capital appreciation and income derived from a diversified mix of preferred stocks and fixed income securities primarily issued by Philippine corporations. The Fund aims to provide returns in excess of the return of the BPI Philippine Corporate Bond Index.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI PERA Corporate Income Fund is suitable only for investors who:

- Are classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years.

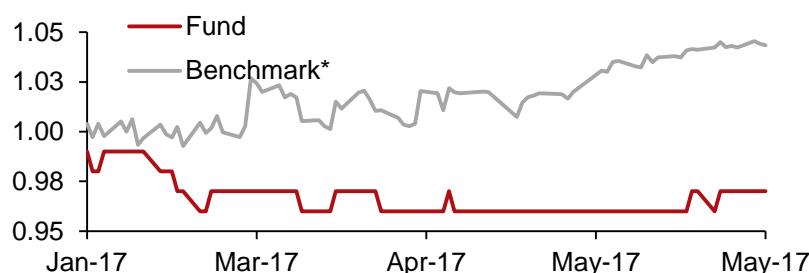

OUTLOOK AND STRATEGY

Market Review. The BPI Government Bond Index rose by 0.07% in May as yields fell by an average of 22 basis points across the curve, with most of the drop seen on the shorter tenors. Compared to the month of April, peso-denominated government bonds were more actively traded with an average daily volume of Php13.1 Bn. Trades were mostly seen on the liquid securities such as the 8.5-year FXTN 10-60, the recently issued 3-year RTB 3-8 and 15-year FXTN 20-17.

The Bureau of the Treasury's three FXTN auctions during the month saw mixed demand as investors remained wary of potentially rising global rates. The first was a new 10-year FXTN issuance (FXTN 10-61), which was awarded at a coupon rate of 4.75% and had an average yield of 4.759%. The government only accepted Php9.72 billion as compared to the Php15 billion initially offered so as to cap the rise in yields. On the other hand, the new issuance of the 20-year FXTN 20-21 showed a healthy turnout, being almost twice oversubscribed. The notes were fully awarded at a coupon rate of 5.25%, with an average yield of 5.104%. The final auction for the month was a new issuance of a 7-year FXTN (7-59) that saw tepid demand. Tenders only amounted to php12.85 billion out of the Php15 billion offer size, and the total accepted amount was just Php4.026 billion. The notes were awarded at a coupon of 4.5%, with an average yield of 4.519%. Yields across all FXTNs sold for the month were higher than previous issuances of the same tenors.

Meanwhile, the average yield on the BSP's 28-day Term Deposit Facility auction held May 24 continued to reflect investors' preference for the 7-day facility as the 28-day tenor remained undersubscribed for the 10th consecutive week. The oversubscribed 7-day deposits were awarded at yields ranging from 3.00% to 3.23%, slightly higher than the prior week's rates.

Philippine inflation came in at 3.4% YoY in April, bringing the year-to-date average to 3.2%. Stable consumer prices allowed the BSP to keep rates on hold during its monetary policy meeting for the month, and maintain their inflation forecasts for FY 2017 and 2018. Globally, investors continued to monitor rhetoric from the Federal Reserve members, as well as developments on geopolitical issues in the US, the Middle East and Russia.

Fund Performance. The Fund returned 1.04% in May, outperforming the benchmark by 1 basis point.

Fund Strategy. The Fund will continue to invest in a diversified mix of securities primarily issued by Philippine corporations.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily tradable fixed-income instruments issued or guaranteed by Philippine corporations; marketable instruments that are traded in an organized exchange; fixed-income instruments issued or guaranteed by the Philippine government or the BSP; investment outlets/ categories the BSP allow. Provided, that, a financial instrument is regarded as tradable if quoted two-way prices are readily available and regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- b) Primarily tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund or any such instrument as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X 410.12 (a) of the Manual of Regulations for Banks.
- c) Shares of preferred stock of selected corporations which are already listed or being offered publicly and soon to be listed in the Philippine stock market.
- d) Bank deposits or tradable debt instruments issued by the BSP.
- e) Such other investments allowed under regulations issued by the BSP.
