INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. The BPI Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

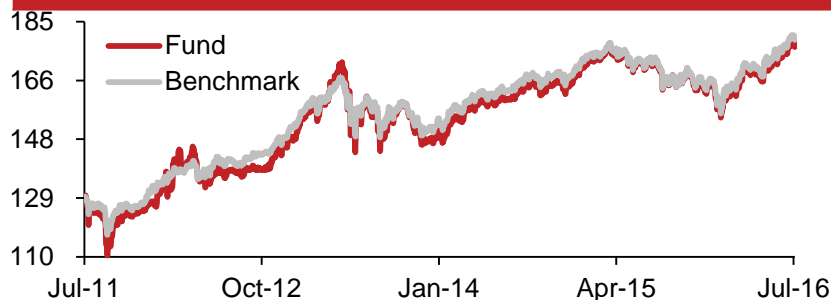

OUTLOOK AND STRATEGY

Market Review. The Philippine Stock Exchange index (“PSEi” or the “Index”) surged in the month of July, climbing 2.14% to 7,963.11 on the back of continuous foreign inflows post-Brexit. Market sentiment was driven by generally accommodative monetary stance from world central banks and positive reinforcement in the new local administration.

Average daily trading volume for the month registered at Php8.31 billion which is considerably higher than the Php7.87 billion recorded a month earlier. Foreigners were net buyers again, netting a US\$418 million for July. In the same month, foreign selling only happened in 3 out of 20 trading days. The year-to-date has now reached a total of US\$1.14 billion almost making up for the US\$1.18 billion net foreign outflow in 2015.

Top index gainers for the month are AGI (+9.19%), RLC (+8.47%), and MEG (+8.17%). Meanwhile, the worst performing index names are BLOOM (-15.66%), SCC (-4.56%) and GLO (-4.38%).

Philippine macroeconomic developments:

- Inflation climbed to 1.9% in June on the back of increase in food prices (+2.9%) and higher utility rates.
- Remittances from overseas Filipino workers accelerated by 2% in May to US\$2.19 billion. This was led by the increase in remittances in Asia (+31%) followed by Middle East (+26%).
- Gross International Reserves (GIR) went higher at US\$83.97 billion in June compared to US\$82.93 billion recorded last May. This was due to higher gold valuations and BSP Forex Operations. This level covers 10.3x months worth of import and 5.9x country’s short-term debt.
- The Budget deficit was reported to be Php45 billion in June, wider than the Php18 billion deficit registered in the prior month. Revenue went up by 7.5% YoY but was pulled down by the decrease in non-tax income collections (-27%). Government spending, meanwhile, plunged 6.5% YoY but last year’ figure included a P32.5bn subsidy to Phil Health.

Fund Performance. The fund rose by 1.01% in July, missing its benchmark by 12 basis points. It underperforms the benchmark on a year-to-date basis by 50 basis points with a return of 7.25%.

Fund Strategy. We remain optimistic in Philippine equities in view that it will reach fresh all-time highs in the second half of 2016 on the back of strong foreign liquidity inflows. Yield-searching across the globe could prompt flows to move out of Europe and back to select Emerging Markets. Likewise, major central banks should also announce more stimulus measures that will bode well for Emerging Markets. On the local front, a high GDP result in mid-August could propel the market to finally break out to new highs. However, second quarter earnings results will dictate the duration of the market consolidation in the meantime.

- (a) Shares of Stock of selected corporations which are already listed or being offered publicly and soon to be listed in major capital markets.
- (b) Primarily medium term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
