INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

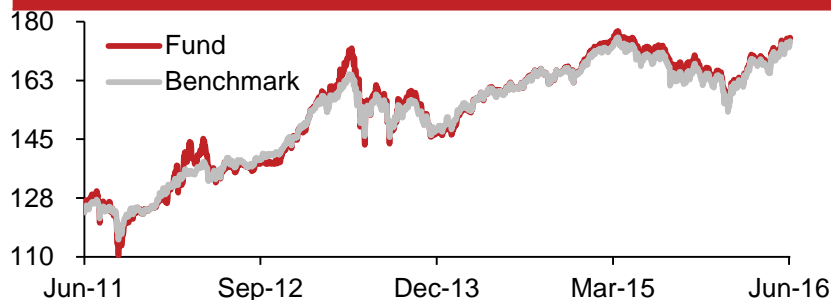

OUTLOOK AND STRATEGY

Market Review. The Philippine Stock Exchange index (“PSEi” or the “Index”) closed at 7,796 gaining 5.3% during the month of June 2016. Investors focused on the surprising win of Brexit, while locals welcomed the new Duterte administration. Global markets tumbled after the UK unexpectedly voted to leave the EU, while polls ahead of the referendum showed a preference to remain. Preference, however, quickly shifted to emerging market assets as the Fed is expected to keep rates lower for longer as more headwinds prevail. Average daily trading volume for the month was declined to USD162m from USD191m the previous month. Foreigners were net buyers during the month of June, with a net inflow position of USD309m. Top index gainers for the month are BLOOM (+62.75%), MPI (+14.83%), SMPH (+12.35%), TEL (+10.54%), and LTG (+9.49%). Worst performing index names are PCOR (-6.23%), AGI (-3.90%), GLO (-3.18%), SCC (-2.27%), and EMP (-2.03%). Philippine macroeconomic developments in June 2016:

- President Rodrigo Duterte took his oath as the 16th President of the Republic of the Philippines.
- The ten-point economic agenda will prioritize inclusive growth
- Tax reform is a priority of the new administration, with the goal of reducing income taxes while improving revenues through imposing additional taxes on oil, junk food, and updating zonal values.
- Infra spending is also a key priority, with the new administration raising infra spending to 5% of GDP.
- Further, the new administration may peg the budget gap to 3% of GDP from the 2% ceiling of the Aquino administration. This is to improve government spending on noteworthy projects.
- BSP keeps rates steady at 3.5% for overnight lending, 3% for overnight reverse repurchase, and 2.5% for overnight deposit facility. Meanwhile, the first auction of the BSP’s new term deposit facility (TDF) yielded a rate of 2.5% as it was oversubscribed by more than 6x on both the 7- and 28-day deposits. .
- Inflation accelerated to 1.6% in May following a jump in food prices impacted by El Nino.
- OFW remittances in April climbed 4.1% year on year to USD2.21b. Remittances from Asia grew 29% while flows from the US declined by 19%.
- Imports rose 29% in April as all major commodities recorded substantial increases.
- Loan growth of commercial banks expanded by 15.6% YoY in April led by real estate (+20.5%) and utilities (+30.6%).
- Vehicle sales continue to rise, with May seeing sales growth at 30.3%.
- BoP position in May reached a surplus of USD148m boosted by income from offshore investments and BSP operations.

Fund Performance. The fund rose by 2.64% in June, missing its benchmark by 8 basis points. It underperforms the benchmark on a year-to-date basis by 37 basis points with a return of 6.18%.

Fund Strategy. Election uncertainties turned into euphoria, clearing the way for a strong rally in Philippine equities in the 2nd week of May. Local valuations traded at a premium to peer Asian markets but investors remain comfortable moving into 2017 earnings expectations. We expect the market to trade higher after showing some resilience at the 7,400 support level. Trading possibilities abound as the PSEi is expected to continue its historic long term uptrend 12 months after a Presidential election. Selected large caps that are expected to release strong 2Q2016 earnings will outperform this market in 2H2016.

- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
