

BPI Balanced Fund

A Unit Investment Trust Fund of the Bank of the Philippine Islands

Investment Objective

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax.

Manager's Report

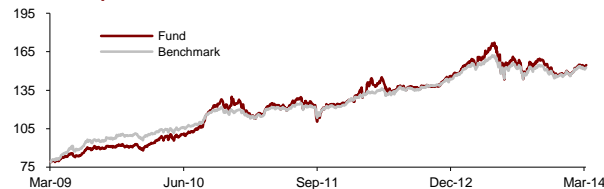
Market Review. The Philippine Stock Exchange Index (PSEi) ended flat for the month of March at 6,428.71 level, an increase of 0.06%. Year-to-date, the PSEi is up 9.15%, still lagging Indonesia (+11.56%) and Vietnam (+17.23%). EM stocks declined after Janet Yellen's FOMC speech suggesting a more hawkish tone. The US Central Bank predicted their target interest rate will be 1.00% by end-2015 and 2.25% a year later, higher than previous forecast. In response, the Bangko Sentral ng Pilipinas (BSP) maintained policy rates but increased reserve requirements by 100 basis points. This signaled the start of BSP's tightening in monetary policy, dampening market sentiment.

Foreign net buying for the month of March was at US\$428 million, reversing the net outflow position in the first two months of the year. This is also the largest net foreign inflow since May last year. Year-to-date, net foreign inflow stands at US\$393 million.

Fund Performance. The Fund gained 0.77% for the month against its benchmark's return of 0.06%.

Strategy. Looking forward, the local equity market may be due for a much needed correction as Philippine stocks have risen close to 12% YTD. Philippine stocks are now valued at 18x P/E multiple estimated 2014 earnings, a huge premium to regional peers. We will ride the momentum of strong foreign flows but will begin taking profits as the Philippine market is reaching irrationally exuberant levels. We continue to overweight the property sector given superior earnings growth.

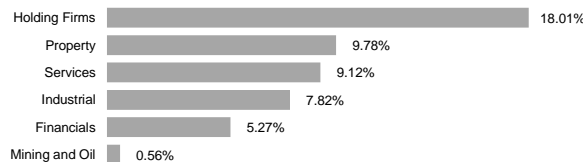
