

BPI Balanced Fund

A Unit Investment Trust Fund of the Bank of the Philippine Islands

Investment Objective

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax.

Manager's Report

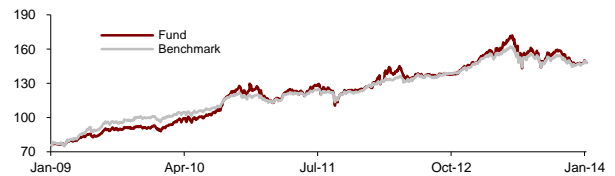
Market Review. The local bourse traded sideways for most of January, as investors searched for catalysts to push the index above the 6,000 resistance level. Strong GDP numbers elevated sentiment towards the end of the month as bargain-hunters began to pick up oversold issues. The PSEi closed at 6,041.19, 2.6% higher than last Decembers' close.

Despite the rise in sentiment, volumes continued to thin, averaging about US\$128 million daily – 34% lower than 2013's average daily volume of US\$194 million. Foreign flows also continued to be negative with about US\$107 million exiting in January. Macroeconomic factors, on the other hand, remained positive. 4Q13 GDP figures surprised on the upside, rising 6.5% YoY versus market consensus of 6.0%. Moreover, full-year GDP grew a respectable 7.2%, higher than last year's 6.8%. Top contributors for the month include BDO (+15.2%), ALI (+5.9%), BPI (+6.5%), and LTG (+19.2%), mostly on local support.

Fund Performance. The Fund gained 1.07% for the month against its benchmark's return of 1.30%.

Strategy. Looking forward, the local equity market may face additional headwinds and will most likely be influenced by developments in the US, the direction of foreign flows, and capital raising activities by financial institutions. We continue to take a defensive stance, stock-picking on value and taking profit on strong rallies.

Portfolio Allocation: Equities 47.65%, Fixed Income 38.82% and Cash and Other Receivables 13.53%

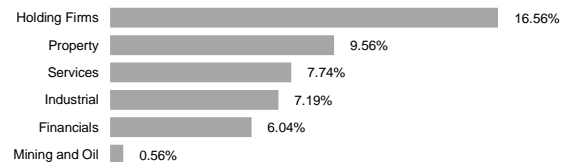
