

#### Investment Objective

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax.

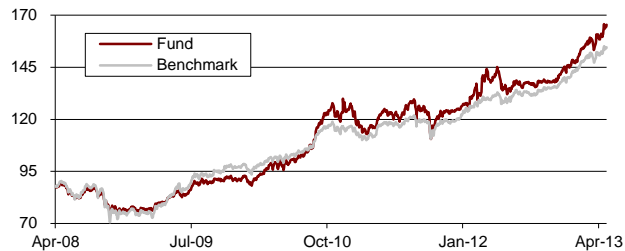

#### Manager's Report

**Local Market Review:** The PSEi recorded its eighth consecutive month-on-month gain this April after it closed at 7070.99, 3.26% higher than last month's levels and 100 bps better than regional benchmark of 2.6%. The Philippine market remains the best performing market in Asia with a YTD gain of 21.64%, albeit with much richer valuations.

The market's strength may be attributable to continued euphoria from Fitch's upgrade last March, S&P's recent GDP forecast upgrade, the BSP's reduction of SDA rates to 2.0%, and strong 1Q2013 earnings indications for banks and consumer companies. Outperformers for the month include conglomerates AC (+13.3%), AGI (+13.3%), and JGS (+11.8%) which serve as proxies for the Philippine economy and high yield plays such as GLO (+19.2%) and MER (+14.5%).

**Fund Performance:** The Fund advanced by 2.91% during the month against its benchmark's 1.64% gain.

**Strategy:** Given the current environment, we have recently upgraded our best case index target from 7,200 to 7,700 based on 17% EPS growth and P/E ratio of 19.5x. We maintain our strategy to buy on dips and retain our overweight calls on large cap issues such as MBT, ALI, and AC. Furthermore, we believe the fund is in a position to benefit from the recent upgrade to investment grade status with our sectoral overweight calls on banks, conglomerates, property, and consumer names.
