#### INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

#### CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. The BPI Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

#### KEY RISKS AND RISK MANAGEMENT

<b>Interest Rate Risk:</b>	Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. 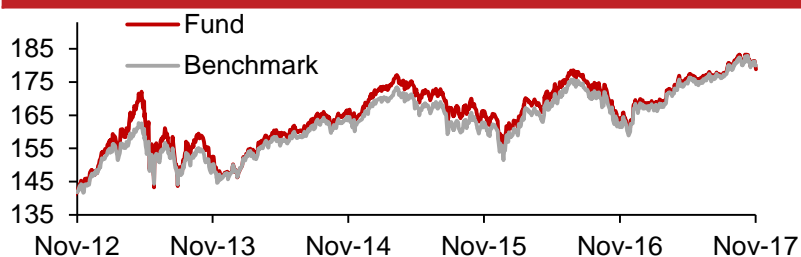

## OUTLOOK AND STRATEGY

**Market Review.** The Philippine Stock Exchange (PSEi) dropped by 1.33% MoM at end-November dragged by foreign outflows. Net foreign selling for the month registered at US\$28 million tracking regional outflows (Indonesia –US\$1.4bn, Thailand –US\$581.1mn and Malaysia –US\$17.8mn). Not to be overlooked, there were a number of positive catalysts during the period including:

- Surprisingly better than expected 3Q2017 GDP @ 6.9%
- Improving 3Q corporate earnings results – companies and sectors were mostly in-line and ahead. Best quarterly results for the year thus far.
- Progressing TRAIN (Tax Reform for Acceleration and Inclusion) – the Senate finally approved the third and final reading of the SB 1592. This is on track for January 2018 implementation

**Fund Performance.** The fund fell 0.75% in November, underperforming its benchmark by 19 basis points. It underperforms the benchmark on a year-to-date basis by 74 basis points with a return of 10.20%.

**Fund Strategy.** Given the record-highs of the PSEi, expectations of a sustained economic growth, steady corporate earnings expansion and coupled with the fact that global growth has been gaining traction, we will be strategically weighted on equities for the next 12 months. We will also take advantage on buying on during this market correction to add on position on equities given our long term view. Furthermore, we will look to tactically switch from overvalued conglomerates to their more attractive subsidiaries.

- (a) Shares of Stock of selected corporations which are already listed or being offered publicly and soon to be listed in major capital markets.
- (b) Primarily medium term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
