INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk:	Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. Factors/ events that may lead to a rise interest rates include adverse market conditions, issuer-specific factors/ events and/ or negative developments in domestic political and economic conditions.

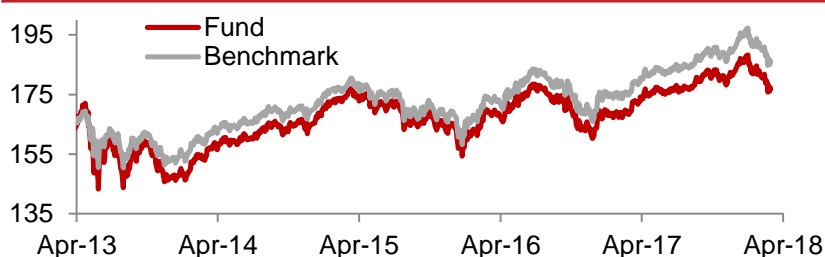

OUTLOOK AND STRATEGY

Market Review. The local equities market came out having a deeper decline, dropping by 2% month-on-month to 7,819.25 in April. Foreign funds continued to exit the market on renewed concerns over rising inflation, depreciating peso, and the lack of response from the central bank to mitigate these. The market was thinner in volumes, having an average daily value turnover of Php5.96 billion or 24% lower compared to the prior month.

Foreign selling persisted, netting US\$170.6 million for April and translating to a net foreign outflow of US\$792 million for the year. Funds have been flocking out in search for higher yields elsewhere.

Top index gainers for the month include LTG (+7.45%), SMC (+4.48%), and AEV (+3.48%). Meanwhile, worst performing index names were ICT (-15.40%), SECB (-12.92%), and RLC (-10.23%).

Fund Performance. The fund fell 1.07% in April, underperforming its benchmark by 18 basis points. It underperforms the benchmark on a year-to-date basis by 88 basis points with a return of -4.80%.

Fund Strategy. In the midst of this market correction, we look to stay defensive in the short-term while taking the opportunity to buy on dips on names that will benefit from the Philippine growth story. Over the long-term, we still prefer large cap conglomerates that emulate the economy. Sector wise, we favor consumer names that benefit from TRAIN 1, infrastructure proxies while being cautious on banks, utilities and telecommunications..

- (a) Shares of Stock of selected corporations which are already listed or being offered publicly and soon to be listed in major capital markets.
- (b) Primarily medium term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
