#### INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

#### CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. The BPI Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

#### KEY RISKS AND RISK MANAGEMENT

<b>Interest Rate Risk:</b>	Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. 

## OUTLOOK AND STRATEGY

**Market Review.** The Philippine Stock Exchange (PSEi) started strong; rising 2.40% month-on-month to close at 8,764.01. Optimism both by local and foreign investors advanced the market. The index clocked in fresh highs during the last week of the month, hitting an all-time high of 9,058.62. Foreigners were net buyers at USD45.2 million or Php2.3 billion despite the weakness in the peso (Php51.295 to a dollar from Php49.85). However, the gains were tempered as investors took some profits off the table especially following the sell-off in global bonds and equities.

Top gainers for the month include SMC (+29.0%), LTG (+19.8%), and JFC (+12.6%). Meanwhile, detractors were BDO (-6.7%), FGEN (-6.0%), and MPI (-5.7%).

**Fund Performance.** The fund rose 0.70% in January, underperforming its benchmark by 159 basis points. It underperforms the benchmark on a year-to-date basis by 159 basis points with a return of 0.70%.

**Fund Strategy.** We remain strategically weighted on equities on the back of our expectations of sustained economic growth, continued earnings expansion, and stabilizing global growth picture. Further, we prefer large cap, highly liquid names to ride the passive inflows expected to come into the market. We view dips in the market as healthy corrections in the overall uptrend of the stock market.

- (b) Primarily medium term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
