INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk: Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. Factors/ events that may lead to a rise interest rates include adverse market conditions, issuer-specific factors/ events and/ or negative developments in domestic political and economic conditions.

Equity Price Risk: Investors are exposed to adverse changes in the prices of stocks listed in the Philippine Stock Exchange, which may be brought about by adverse stock market conditions, unfavorable company earnings and valuations and/ or negative developments in domestic and global political and economic conditions.

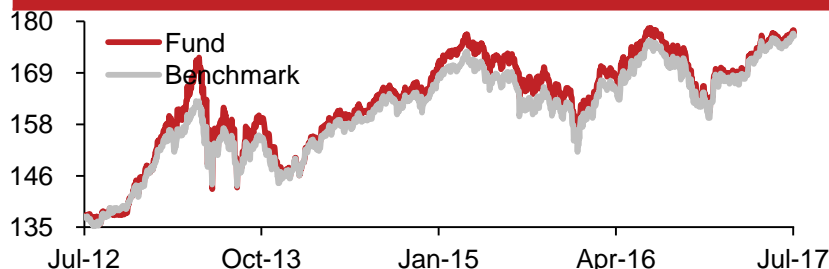

RELATED PARTY TRANSACTIONS*

OUTLOOK AND STRATEGY

Market Review. The Philippine Stock Exchange Index (PSEi) soared above the 8,000 mark for the month of July, 2.23% higher MoM mostly on bargain hunting by both locals and foreigners. However, foreign participation was much subdued ahead of the ghost month, accounting only to roughly 47% of the PSEi. Foreign buying registered at US\$38 million.

Top gainers for the month include LTG (+19.73%), DMC (+14.18%), and MEG (+11.63%). Worst performing index names include TEL (-8.95%), FGEN (-8.47%), and SMC (-2.31%).

Key Economic Developments:

- The President delivered his second SONA on the latter part of the month where he lobbied for the fast-tracking implementation of the Comprehensive Tax Reform Program (CTRP) and reiterated plans to increase infrastructure spending to 7% of GDP by 2022.
- OFW remittances inched up by 5.5% to US\$2.31bn in May which is attributed to remittances from the Middle East (+14.2%).
- Inflation slows down to 2.8% in June from 3.1% in May. The decline is mostly due to the deceleration in housing, water, electricity, gas and fuel decelerated to 2.1% in June from 3.6% in May.

Fund Performance. The fund rose by 1.05% in July, missing its benchmark by 16 basis points. It underperforms the benchmark on a year-to-date basis by 40 basis points with a return of 8.56%.

Fund Strategy. We remain neutral on equities and continue to take profits. We'll continue to be nimble and opportunistic on strong market flows. We'll also focus on undervalued conglomerates and companies that might potentially be positive surprises during the 2Q earnings season.

- (b) Primarily medium term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
