INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve long-term capital growth by investing in a diversified portfolio of equity and fixed income securities. The Fund aims to provide excess return over the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% return of the 91-day Philippine Treasury Bill, net of tax

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI Balanced Fund is suitable for investors who:

- Are at least classified as aggressive based on their risk profile
- Have an investment horizon at least five (5) years

Interest Rate Risk:	Investors are exposed to adverse changes in the prices of domestic fixed income securities due to a rise in interest rates, which generally causes fixed income security prices to decline. 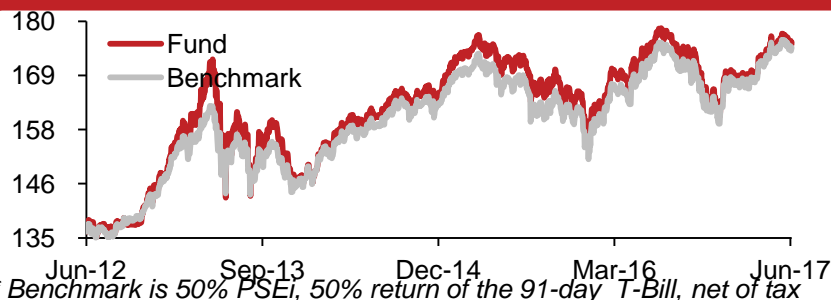

RELATED PARTY TRANSACTIONS*

OUTLOOK AND STRATEGY

Market Review. The Philippine Stock Exchange index (“PSEi” or the “Index”) traded sideways in June hovering around the 8,000 level, ending with a small gain 0.08% to end at 7,843.16. After a quick 3% rally in the first few days, the market succumbed to profit taking mostly from local investors. Foreigners were actually net buyers for the third consecutive month, with year-to-date inflows now amounting to US\$386m.

The US Fed raised interest rates for the 2nd time this year by another 0.25%. Consensus estimates at least another before 2017 ends. Locally, the Philippine Peso hit 10-year low as the BSP guided that it is expecting the current account to turn to a deficit position this year versus the original forecast of a surplus. The BSP also kept the policy rate and reserve requirement ratio unchanged at 3.0% and 20% respectively.

Top gainers for the month include DMC (+4.91%), SM (+4.29%), and TEL (+4.05%). Worst performing index names include PCOR (-11.84%), MEG (-8.51%), and LTG (-8.13%).

Key Economic Developments:

- BSP meanwhile kept rates unchanged, while trimming inflation forecast to 3.1% (from 3.4%) in 2017 and expects 2-4% inflation in 2018

- Inflation slows to 3.1% in May from 3.4% the previous month due to slight deceleration in food inflation from +4.2% to only +3.8%

- The tax reform package 1 has been passed by the lower house this month, now for submission to the Senate for fresh deliberation when congress reconvenes on July 24

- Budget deficit widens to PHP33.4b in May from PHP17b last year. Stronger spending was attributed to midyear bonuses such as the PHP32.6b given to military and uniformed personnel.

Fund Performance. The fund rose by 0.06% in June, missing its benchmark by 6 basis points. It underperforms the benchmark on a year-to-date basis by 23 basis points with a return of 7.43%.

Fund Strategy. We remain neutral on equities and continue to take profits as we overshoot the 8,100 level (at 19.5x P/E). We'll continue to be opportunistic on strong market flows focusing on undervalued conglomerates and companies that might potentially be positive surprises come 2Q earnings season.

- (b) Primarily medium term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (c) Primarily medium term tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund.
- (d) Bank deposits and such other investments allowed under regulations issued by the BSP.
