INVESTMENT OBJECTIVE AND STRATEGY

The Fund intends to achieve for its participants capital appreciation and income derived from a diversified mix of preferred stocks and fixed income securities primarily issued by Philippine corporations. The Fund aims to provide returns in excess of the return of the BPI Philippine Corporate Bond Index.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI PERA Corporate Income Fund is suitable only for investors who:

- Are classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years.

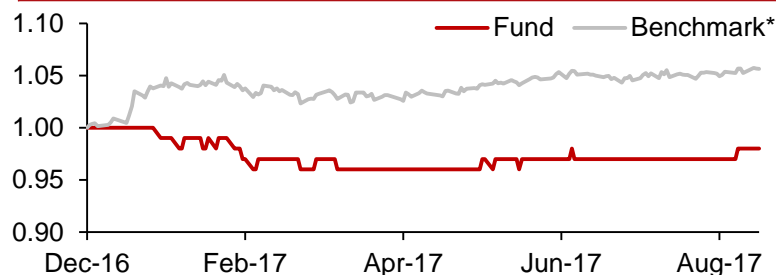

RELATED PARTY TRANSACTIONS

The Fund has transactions and outstanding investments including deposits, investment in the share/s of stocks, and/or debt issuances of the following companies related to the BPI Asset Management and Trust Corporation (BPI AMTC):

OUTLOOK AND STRATEGY

Market Review. The BPI Government Bond Index rose by 0.44% in August as yields fell by an average of 8 basis points across the curve. Compared to the month of July, peso-denominated government bonds were more actively traded with an average daily volume of Php11.12 Bn. Trades were mostly seen on the liquid securities such as the 8-year FXTN 10-60, and the shorter-tenored 3-year RTB 3-8 and the 9-month FXTN 5-72.

The Bureau of the Treasury's two FXTN auctions during the month saw strong demand as investors looked to take positions on the belly of the curve. The first was a re-issuance of the 7-year FXTN 7-59, which was awarded at an average yield of 4.510%, only slightly lower than the previous auction's 4.519%. The auction was fully awarded at Php15 billion, with total tenders amounting to Php33.885 billion. The re-issuance of the 10-year FXTN 10-61 likewise showed a healthy turnout, being almost twice oversubscribed. However, investors bid higher as the resulting average yield came in at 4.178%, up by 2.6 basis points from the first reissuance in June.

During the month, cautious trading was seen as investors awaited the widely-watched Jackson Hole Economic Symposium, held last August 24-26. During this three-day event, central bankers such as US Federal Reserve Chair Janet Yellen and European Central Bank President Mario Draghi shared their thoughts on financial stability. In her speech, Yellen stated that while the financial system is safer now than before, some adjustments may still be necessary moving forward. Meanwhile, Draghi remarked that global recovery is firming up. Over-all, statements made during the symposium were mostly within market expectations.

On the local front, Philippine inflation came in at 2.8% YoY in July, bringing the year-to-date average inflation to 3.1%. The country's second quarter GDP growth figure was also released mid-August, coming in at 6.5% YoY. This was faster than the 6.4% increase in 1Q17, and ahead of consensus estimate of 6.4%. Stable consumer prices and solid GDP growth allowed the BSP to keep rates on hold during its monetary policy meeting for the month, while increasing its inflation expectations slightly from 3.1% to 3.2% for the year. Globally, investors continued to monitor developments on geopolitical issues in the US and North Korea.

Fund Performance. The Fund outperformed its benchmark by 49 bps in August.

Fund Strategy. The Fund will continue to invest in a diversified mix of securities primarily issued by Philippine corporations.

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily tradable fixed-income instruments issued or guaranteed by Philippine corporations; marketable instruments that are traded in an organized exchange; fixed-income instruments issued or guaranteed by the Philippine government or the BSP; investment outlets/ categories the BSP allow. Provided, that, a financial instrument is regarded as tradable if quoted two-way prices are readily available and regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- b) Primarily tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund or any such instrument as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X 410.12 (a) of the Manual of Regulations for Banks.
- c) Shares of preferred stock of selected corporations which are already listed or being offered publicly and soon to be listed in the Philippine stock market.
- d) Bank deposits or tradable debt instruments issued by the BSP.
- e) Such other investments allowed under regulations issued by the BSP.
