INVESTMENT OBJECTIVE AND STRATEGY

The Fund intends to achieve for its participants capital appreciation and income derived from a diversified mix of preferred stocks and fixed income securities primarily issued by Philippine corporations. The Fund aims to provide returns in excess of the return of the BPI Philippine Corporate Bond Index.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI PERA Corporate Income Fund is suitable only for investors who:

- Are classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years.

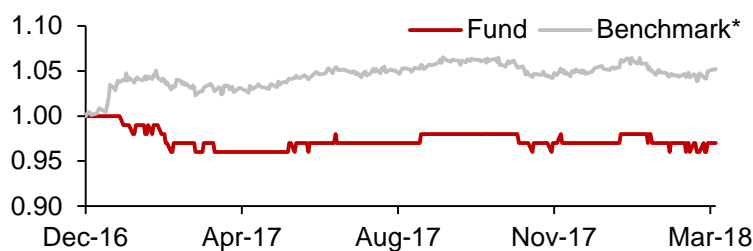

RELATED PARTY TRANSACTIONS

The Fund has transactions and outstanding investments including deposits, investment in the share/s of stocks, and/or debt issuances of the following companies related to the BPI Asset Management and Trust Corporation (BPI AMTC): Ayala Corp.– PHP 0.31mn, Globe Telecommunications, Inc. - PHP 0.07mn and Ayala Land, Inc. – PHP 0.35mn Investments in the said outlets were approved by the BPI AMTC's Board of Directors. Likewise, all related party transactions are conducted on an arm's length and best execution basis and within established limits.

OUTLOOK AND STRATEGY

Market Review. The BPI Government Bond Index marginally rose by 0.32% in March as yields fell by 12 basis points on average. Similar to the month of February, peso-denominated government bonds were not very actively traded with an average daily volume of Php7.56 billion. Trades were mostly seen on the liquid securities such as the 5-year RTB5-11, the 14-year 20-17, and the shorter-tenored 2-year FXTN 7-56.

The Bureau of the Treasury's two FXTN auctions during the month saw moderately strong demand even as investors remained cautious amid expectations of rising interest rates globally, and talks of impending supply. The first was a new 5-year FXTN issuance (FXTN5-75), which was only partially accepted by the BTr. The auction was oversubscribed with total bids amounting to Php25.9 billion relative to the Php20 billion auction size. A total of Php12.04 billion was accepted by the BTr, with an average coupon of 5.500% and an average yield of 5.452%, compared to the 4.625% yield of the RTB 5-11 issuance last December 2017. Had the paper been fully awarded, the coupon rate would have reached 5.75%.

The second auction, a new issuance of a 10-year paper (FXTN10-63), was partially awarded at an average yield of 6.184%, with a coupon rate of 6.25%. Only Php7.990 billion out of the Php20 billion initial offer was accepted. Bids amounted to Php22.806 billion. The average yield was 127 basis points higher than the last successful 10-year bond auction (FXTN10-61 re-issuance), causing market players to sell off on the long end of the curve.

On the local front, inflation for the month of February surged to a three-year high of 4.5%, driven by rising prices in food, drinks and tobacco. The increase in consumer prices was due to continued effects of the recently implemented Tax Reform for Acceleration and Inclusion (TRAIN) law. While the figure exceeded the central bank's targeted range of 2-4% for the year, the Bangko Sentral ng Pilipinas assured investors that the spike was transitory and that the longer-term inflation outlook was still intact.

Fund Performance. The Fund underperformed its benchmark by 69 bps in March.

Fund Strategy. The Fund will continue to invest in a diversified mix of securities primarily issued by Philippine corporations.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily tradable fixed-income instruments issued or guaranteed by Philippine corporations; marketable instruments that are traded in an organized exchange; fixed-income instruments issued or guaranteed by the Philippine government or the BSP; investment outlets/ categories the BSP allow. Provided, that, a financial instrument is regarded as tradable if quoted two-way prices are readily available and regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- b) Primarily tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund or any such instrument as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X 410.12 (a) of the Manual of Regulations for Banks.
- c) Shares of preferred stock of selected corporations which are already listed or being offered publicly and soon to be listed in the Philippine stock market.
- d) Bank deposits or tradable debt instruments issued by the BSP.
- e) Such other investments allowed under regulations issued by the BSP.
