INVESTMENT OBJECTIVE AND STRATEGY

The Fund intends to achieve for its participants capital appreciation and income derived from a diversified mix of preferred stocks and fixed income securities primarily issued by Philippine corporations. The Fund aims to provide returns in excess of the return of the BPI Philippine Corporate Bond Index.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust / Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

The BPI PERA Corporate Income Fund is suitable only for investors who:

- Are classified as aggressive based on their risk profile
- Have an investment horizon of at least five (5) years.

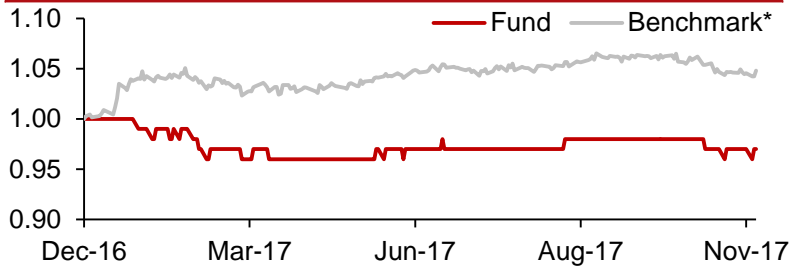

RELATED PARTY TRANSACTIONS

The Fund has transactions and outstanding investments including deposits, investment in the share/s of stocks, and/or debt issuances of the following companies related to the BPI Asset Management and Trust Corporation (BPI AMTC): Ayala Corp. – PHP 0.18mn, Globe Telecommunications, Inc. - PHP 0.05mn and Ayala Land, Inc. – PHP 0.26mn Investments in the said outlets were approved by the BPI AMTC's Board of Directors. Likewise, all related party transactions are conducted on an arm's length and best execution basis and within established limits.

OUTLOOK AND STRATEGY

Market Review. The BPI Government Bond Index fell by 1.94% in November as yields rose by an average of 45 basis points, with most of the drop seen on the short and long end of the curve. Compared to the month of October, peso-denominated government bonds were less actively traded with an average daily volume of Php5.54 Bn. Trades were mostly seen on the liquid securities such as the 3-year RTB 3-8, 4-year FXTN 5-74, and 8-year FXTN 10-60.

The Bureau of the Treasury (BTr) increased the volume of the remaining T-Bill and FXTN auctions in 2017 from Php15 billion to Php 20 billion. Two auctions were held in November. The first auction, which was a re-issuance of the 9.5-year FXTN 10-61, was awarded at an average yield of 4.915%, which was higher than the previous auction's 4.647%. Only half of Php20 billion offer was awarded, even as the total bids amounted to Php32.6 billion. The second auction was a new issuance of a 5-year Retail Treasury Bond (RTB 5-11). The RTB 5-11 was one of the largest RTB issuances seen in recent years with a total issue size of Php255.4 billion, and had a coupon of 4.625%.

The local inflation print came in at 3.5% YoY in October, the highest figure recorded since November 2014. The inflation figure, which was well within the BSP's target range of 2% to 4%, was mainly driven by price pressures on fuel, food and a weaker Philippine Peso. The country's third quarter GDP growth figure was also released mid-November, coming in at 6.9% YoY and beating market expectations of 6.6%. The Bangko Sentral ng Pilipinas (BSP) cut the offer size of its Term Deposit Facility (TDF) to Php80 billion from Php130 billion starting December 6, 2017.

Fund Performance. The Fund outperforming its benchmark by 29 bps in November.

Fund Strategy. The Fund will continue to invest in a diversified mix of securities primarily issued by Philippine corporations.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Primarily tradable fixed-income instruments issued or guaranteed by Philippine corporations; marketable instruments that are traded in an organized exchange; fixed-income instruments issued or guaranteed by the Philippine government or the BSP; investment outlets/ categories the BSP allow. Provided, that, a financial instrument is regarded as tradable if quoted two-way prices are readily available and regularly available from an exchange, dealer, broker, industry group, pricing service or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.
- b) Primarily tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund or any such instrument as may be allowed under BSP regulations. Investment with related interests shall be in accordance with Subsection X 410.12 (a) of the Manual of Regulations for Banks.
- c) Shares of preferred stock of selected corporations which are already listed or being offered publicly and soon to be listed in the Philippine stock market.
- d) Bank deposits or tradable debt instruments issued by the BSP.
- e) Such other investments allowed under regulations issued by the BSP.
