

Fund Manager's Report

US dollar-denominated ROP bond prices rallied as yields declined by an average of 13bps, supported by increased market liquidity amidst the maturity of the ROP10 Euro and by the successful issuance of Yen-denominated ROP debt. Some investors may have converted the proceeds of the EUR650Mn ROP that matured on February 21 to USD amidst worries over the Euro zone. Fiscal problems in Portugal, Italy, Ireland, Greece and Spain have been in recent focus, leading to speculation of sovereign credit rating downgrades and possible defaults. Meanwhile, the Philippines successfully issued USD1.1Bn worth of Samurai bonds on February 23, thus achieving its foreign borrowing plan for the year.

Against this backdrop, the Fund continued to track the returns and duration of the index in February. Investors of the Fund are advised to pursue a long-term investment horizon.


Net Asset Value Per Unit

The higher the duration, the more NAVpu will fluctuate in relation to changes in interest rates. Volatility measures the fluctuations in NAVpu.
