INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve investment returns that closely track the total return of a U.S. dollar-denominated index, the JP Morgan Asia Credit Philippines Total Return Index, before fees and taxes, by investing in a diversified portfolio of Philippine sovereign and corporate fixed income instruments.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest. The Fund is for investors who:

- are at least classified as aggressive based on their risk profile
- have an investment horizon of more than seven (7) years

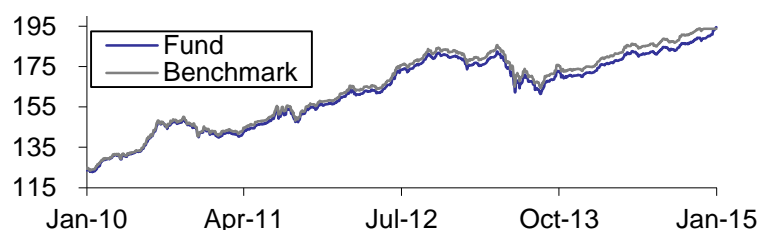

OUTLOOK AND STRATEGY

Market Review. The JP Morgan Chase Asia Total Return Philippine Bond Index gained by 2.78% in January. Philippine sovereign bonds advanced in a month headlined by the European Central Bank's quantitative easing program and anti-austerity party Syriza winning Greece's national elections. Prices of ROPs went up by an average of 2.94 points. Ten-year US Treasury eased by 55 basis points to 1.64%.

The European Central Bank finally announced a massive asset purchase program after holding back in the prior meetings despite sluggish growth and low inflation in the region. The \$70 billion-a-month buying program exceeded expectations, helping markets around the globe, including the Philippines, reach record highs.

Meanwhile, the US Federal Reserve largely retained its policy guidance saying it can be patient in beginning to normalize the monetary policy. Though it upgraded its view of the pace of US economic growth to "solid" from "moderate".

Philippine economy grew by 6.9% in the fourth quarter, rebounding from the previous quarter's 5.3% expansion. This brought full-year growth up to 6.1%, but still fell short of the government's 6.5-7.5% target. Government spending improved, increasing by 9.8% compared to the 2.6% contraction in the previous quarter.

The Philippines issued \$2-billion worth of global bonds due 2040 with a coupon rate of 3.95%. Three-quarters of the amount was used to swap for existing bonds. A total of \$500 million was raised in new money, below the \$750-million borrowing program for the year.

Fund Performance. Against this backdrop, the fund gained by 2.89% in January.

Fund Strategy. The Fund will continue to closely track the JPMorgan Asia Credit Total Return Index.

RELATED PARTY TRANSACTIONS*

The Fund has transactions and outstanding investments including deposit, investments in the share/s of stock, and/or debt issuances of the following companies related to the Bank of the Philippine Islands:

Bank of the Philippine Islands, International Container Terminal Services, Inc., Philippine Long Distance Telephone Co., and Petron Corporation, First Gen Corporation

Investments in the said outlets were approved by the Trust Committee. Likewise, all related party transactions are conducted on an arm's length and best execution basis and within established limits.

LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- (a) Primarily long term tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP; tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and, such other tradable investment outlets/ categories as the BSP may allow.
- (b) Tradable fixed-income securities issued, underwritten, or otherwise dealt by BPI and/or any of its subsidiaries, affiliates, their successors-in-interest or assignees, their directors, officers, stockholders, and related interest, and any of their trust and fund managed accounts, under such terms and conditions as the Trustee may deem to be in the best interest of the Fund
- (c) Collective investment vehicles managed by reputable fund managers the investment objectives and policies of which are generally consistent with those of the Fund, subject to then existing BSP regulations.
- (d) The principal investments of the Fund will be in fixed-income instruments denominated in, but are not limited to, the following major currencies: U.S. Dollar, Euro, British Pound, Canadian Dollar, Australian Dollar, Swiss Franc, Danish Kroner, and Japanese Yen.
- (e) Bank deposits and such other investments allowed under regulations issued by the BSP.
